EXECUTIVE SUMMARY

This report focuses on the employment and educational outcomes of **302** students who graduated from Peirce College in August 2019, December 2019, and May 2020. Data were obtained from **298** graduates, which represents **98.7%** of the individuals who graduated during this time period.

Of the graduates who responded with their employment status, 220 (74%) are employed, with the majority (169, or 78%) employed in a position related to their field of study. In comparison with the 2018-2019 graduating class, this is a 2% increase in employment and 1% increase in employment within field of study. It should be noted that this data is collected throughout the year, at the time that students conclude their final coursework. Accordingly, reported employment rates may have been affected by the COVID-19 pandemic and not reflected in these numbers.

66% of responding graduates indicated that they earned **over \$40,000 per year**. 44% earned over \$50,000.

Top employers for the 2019-2020 graduating class were the City of Philadelphia (12 employees), Penn Medicine (11 employees), and Jefferson Health Systems (8 employees).

62% of responding graduates were planning to enroll or already were enrolled in continuing education.

Data Collection

The graduate surveys were previously reviewed by Faculty Chairs to ensure that relevant information was collected in order to gain needed information for accreditation by the Association of College Business Schools and Programs (ACBSP) and approval by the American Bar Association (ABA).

Surveys were deployed electronically to graduates several times throughout the year. As needed, additional information may be collected via phone calls, emails, and LinkedIn.

Data Presentation

The percentages for number of students employed and those employed within their field of concentration were tabulated. Comparisons have been made between 2019-20 and the two most recent preceding years in order to fully evaluate outcomes as a group with reference to individual majors. The number of graduates, the number of respondents, their employment status, and educational transfer patterns were compared.

Data reflect self-reported results from graduates that reflect the following areas of study:

2019-2020 GRADUATE SURVEY OVERALL SYNOPSIS

The 2019-2020 Graduate Employment Survey was deployed to **302** graduates, and information was collected for **298** (**98.7**%) graduates. The following is a breakdown of the number of graduates, per concentration, who were sent the survey:

Figure 1. All graduates by program.




Figure 2. Status after Graduation, All Graduates.




Figure 3. Employment rates by program.





Figure 4. Employment type by program.

Figure 5. Salary of All Graduates.





Figure 6. Salary of Graduates by Program.



CONTINUING EDUCATION

Survey recipients were asked about their plans related to continuing education. 52% of graduates who responded to the question planned to enroll in further education, 10% were already enrolled, and 38% had no plans to enroll. Of the 31 students who provided that they were enrolled, 28 provided the institution of enrollment. The majority of these (21 individuals, or 75% of those who provided information) are continuing to pursue their educational goals at Peirce College, with the remaining enrolled at Temple University (2), Chestnut Hill College (1), Drexel University (1), Eastern University (1), Pennsylvania State University (1), and Widener University (1).




Figure 7. Continuing Education Plans by Degree Level.

Certificate Graduates

Nineteen Peirce College students graduated in the 2019-2020 academic year with a certificate, and surveys were sent to all twenty certificate graduates. Seventeen graduates responded to the survey, with a response rate of 89%, and nine provided information about salary range.

Of the 19 certificate graduates, 9 graduated with a certificate in Medical Coding, 4 in Paralegal Studies, 4 in Customer Service, 1 in Cybersecurity, and 1 in Human Resources Management.

Of the 17 graduates who responded, 13 (76%) are employed, with 10 out of 12 (83%) respondents employed within their field of concentration.


Associate Degree Graduates


Surveys were sent to all 70 graduates who earned associate degrees in the 2019-2020 academic year. Information was collected for 70 graduates, with a response rate of 100%.

Of the 70 Peirce College students who graduated in the 2019-2020 academic year with an associate degree, 18 graduated with an A.S. in Business Administration, 12 graduated with an A.S. in Criminal Justice Studies, 8 graduated with an A.A. in General Studies, 17 graduated with an A.S. in Health Information Technology, 6 graduated with an A.S. in Information Technology, 3 graduated with an A.S. in Leadership Development, and 6 graduated with an A.S. in Paralegal Studies.

Of the 18 Business Administration A.S. graduates, 3 graduated with a concentration in Management.

Of the 84 graduates who responded with their employment status, 63 (75%) are employed and 41 (66%) are employed within their field of concentration.





Bachelor of Science Degree Graduates


In the 2019-2020 academic year, **186** Peirce College students graduated with a Bachelor of Science (B.S.) degree. Of the 186 B.S. degree program graduates, 14 graduated with a degree in Accounting, 34 graduated with a degree in Business Administration, 21 graduated with a degree in Criminal Justice, 33 graduated with a degree in Healthcare Administration, 6 graduated with a degree in Health Information Administration, 3 graduated with a degree in Human Resource Management, 23 graduated with a degree in Information Technology, 23 graduated with a degree in Integrated/Organizational Leadership, 1 graduated with a degree in Legal Studies in Business, 1 graduated with a degree in Liberal Studies Medical Coding Track, 24 graduated with a degree in Paralegal Studies, and 3 graduated with a degree in Technology Management.

Of the 38 Business Administration B.S. graduates, 21 graduated with a concentration in Management, 2 graduated with a concentration in Marketing, 1 graduated with a concentration in Professional Studies, 1 graduated with a concentration in Business Law, and 4 graduated with a concentration in Entrepreneurship/Small Business Management.

Of the 23 Information Technology B.S. graduates, 17 graduated with a concentration in Networking/Admin/Information Security, 5 graduated with a concentration in Programming and Application Development, and 1 graduated with a concentration in Information Security - CISSP.

Surveys were sent to 186 B.S. graduates. Information was collected for 184 graduates, with a response rate of 99%.

Of the graduates who responded, 136 (74%) are employed, with 100 (74%) employed within their field of concentration.






Master of Science Degree Graduates

In the 2019-2020 academic year, **27** Peirce College students graduated with a Master of Science (M.S.) degree. 13 received a master's degree in Healthcare Administration and 14 graduates received a degree in Organizational Leadership and Management.

Surveys were sent to 27 M.S. graduates, all of whom responded to the survey; the response rate is 100%.

Of the graduates who responded, 24 are employed (89%), and 22 (92%) are employed within their field of concentration.

TWO-YEAR COMPARISON: 2018-2019 AND 2019-2020 EMPLOYMENT RATES

The two-year comparison highlights only the current degree programs and concentrations offered by Peirce. This review includes associate and bachelor's degrees in Accounting, Business Administration, Criminal Justice Studies, General Studies, Healthcare Administration, Health Information Administration, Health Information Technology, Human Resource Management, Information Technology, Leadership Development, Legal Studies in Business, Liberal Studies: Medical Coding Track, Organizational/Integrated Leadership, Paralegal Studies, and Technology Management as well as certificate programs in Customer Service, Human Resource Management, Information Technology: Cybersecurity, Medical Coding, and Paralegal Studies and master's degrees in Healthcare Administration and Organizational Leadership and Management. Specifically, the report includes statistics related to the number of graduates, the number responding to survey, the number employed, and the number employed in their field of study.

For the **2019-2020** academic year, 302 students graduated within the degree programs and concentrations identified. Of the 302, 98.7% responded to the survey, though some survey questions were left blank. Excluding non-respondents, 220 (74%) are employed and 169 (78%) reported that they are employed within their field of study.

For the **2018-2019** academic year, 318 students graduated within the degree programs and concentrations identified. Of the 318, all 100% responded to the survey, though some survey questions were left blank. Excluding non-respondents, 224 (72%) are employed and 166 (77%) reported that they are employed within their field of study.


