Title: The sad end drowned in the sea of the millionaire heir Benjamin Guggenheim, after saving his lover

He was known as 'the prince of silver' and married another wealthy heiress. However, he had several lovers and with one of them he spent his last hours on the 'Titanic' before dying "like a gentleman."

155 years ago (this Monday, October 26), one of the most remembered entrepreneurs in the United States was born in Pennsylvania: Benjamin Guggenheim. A wealthy heir who invested much of his money in mining projects. Despite this, Guggenheim's historical fame is linked to a reason totally unrelated to his investments: the tycoon died on the Titanic, along with two of his servants, in 1912. In fact, Benjamin Guggenheim's character appears in the film by James Cameron, where he is portrayed as a bohemian man, elegant and also very womanizing.

Meyer Guggenheim - a millionaire dedicated to mining and metallurgy - passed away in 1905, leaving seven heirs: Isaac, Daniel, Murry, Solomon Robert, John Simon and Benjamin. A handsome young man who was interested in growing the family economy, although he was not very talented at doing so. Benjamin initially became interested in mining and entered Columbia College to learn the same trade as his father. However, he found the classes boring, decided to quit, and enrolled to study business at the prestigious Peirce College.

Around this time, Guggenheim began to become a well-known man among the elites and to develop a profile, according to National Geographic, of "playboy and gamer", despite the fact that he was married to Florette Seligman, daughter and heiress of James Seligman, a banker and majority partner of the firm J&W Seligman. "Florette is a very beautiful brunette and the groom is the director of many prominent companies. He is known as The Prince of Silver, due to his interest in mines," wrote the New York Times on their wedding day.

Guggenheim was said to have had several mistresses. What's more, when he got on board the RMS Titanic, bound for New York, he was accompanied by one of them: a French singer named Léontine Aubart. Even so, according to James Etches, a cabin attendant on the Titanic, the American's last words were to his wife: "I was with Guggenheim until the end. I was saved and he sank with the ship. Before he died he told me: 'If something happens to me, tell my wife in New York that I've done everything I can to do my duty.'"

According to the New York Times after the accident, Guggenheim was with his henchman and assistant when the Titanic hit the iceberg. At first he did not give importance to the matter, but ended up putting on a life jacket and went out on deck. Once there, according to Etches's account, he was of vital help to the officers and shouted "women first" to - later - put his mistress and servant in a boat. "See you soon, surely tomorrow the Titanic will work again," he said very calmly. And it is that Guggenheim did not expect a disaster.

"Things weren't so bad at first. But when I saw Mr. Guggenheim, about three-quarters of an hour after the accident, I was surprised that both he and his secretary were dressed in formal clothes. They had taken off their life jackets and he said; ' We have dressed in the best and we are ready to sink like gentlemen, '"Etches said a couple of hours later, already on dry land. There is also another account of the last moments of the tycoon. A letter written by survivor Rose Amélie Icard. "The millionaire Guggenheim, after helping save women and children, put a rose on his suit to die," he wrote.

After his death, the tycoon left three heiresses, including patron Peggy Guggenheim. One of his brothers, Solomon, also became famous as an art collector and in 1937 created the Solomon R. Guggenheim Foundation, architect of the museums of New York, Venice, Berlin and Bilbao. According to their website, they will also open a museum in Abu Dhabi soon.

Title: Shocking moment looters clear out black-owned Philadelphia boutique in one MINUTE during night of chaos

LOOTERS in Philadelphia raided and stripped a black-owned boutique bare in less than a minute, amid protests over police fatally shooting Walter Wallace Jr.

Surveillance camera footage showed about two dozen looters breaking into La'Vanter Boutique in Pennsylvania's largest city on Tuesday night.

First, two women are seen breaking in and grabbing items.

"I hope we do not get caught!" one woman says.

Moments later, at least 20 more people swarm the store, taking clothes and leaving hangers on the floor and picking accessories off the shelves.

"We had everything taken from us in less than a minute," the boutique's owner Jameelah Scurry said on Wednesday, according to the Daily Mail.

Scurry told ABC 6 that "we as black people, really need to reunite and come together" and that "destroying and tearing down our own people is not the answer."

She said she had just come up on the two-year anniversary of opening the boutique and was celebrating it before it was ransacked.

"It's been a rough journey, selling our house, moving, to get the money together to start our dream," she said.

"We are now in danger of losing everything we worked so hard for."

It was the second time the boutique has been looted.

The first break-in occurred on August 27 when protests erupted over the officer-involved shooting of Jacob Blake.

Scurry said she graduated from Peirce College and left her job, maxed out her credit cards, drained her savings account and sold her house to open the boutique because she wanted to invest in her "dreams and community."

A GoFundMe fundraiser launched on Wednesday for Scurry had garnered more than \$28,000 by Thursday night.

“It's been a real blessing,” Scurry said.

“I appreciate everybody that reached out to even give us encouraging words and that are praying for us.”

The boutique was just one of at least 200 small businesses that have reportedly been targeted by looters.

Civil unrest and peaceful protest emerged in Philadelphia in response to police shooting Wallace Jr, 27, who had approached them with a knife on Monday afternoon.

Wallace Jr's family said he had bipolar disease and that they had called an ambulance to help him with a mental health emergency.

Instead, cops who responded “butchered” Wallace Jr, his father Walter Wallace Sr said.

‘We are now in danger of losing everything we worked so hard for.’

A Philadelphia businesswoman says it took looters about a minute to snatch up everything inside her boutique Tuesday during the city’s unrest over the police killing of 27-year-old Walter Wallace Jr..

Jameelah Scurry’s La’Vanter Boutique was reportedly among the nearly 200 small businesses targeted by vandals. The destruction occurred just as her company celebrated its two-year anniversary in the community.

“We were also celebrating that and our two-year mark in business,” Scurry shared with local reporters, per 6ABC.com.

The Peirce College graduate quit her job, sold her home, maxed out her credit cards and invested her entire savings into her boutique. She even survived the challenges of the coronavirus pandemic. This latest setback could force her to close the doors to La’Vanter for good.

“Me graduating from Peirce, that was a long journey too,” Scurry said. “I was actually very proud of myself, graduating in a pandemic. It was extremely hard with all of the George Floyd riots and all of that going on.”

Community members are supporting Scurry with her rebuilding efforts via a campaign on GoFundMe.

“I quit my job and decided to invest in my dreams and community. I emptied my savings and checking account. Maxed out credit cards and sold my house to open my business,” the campaign page states.

Scurry’s boutique was previously burglarized in August, “which set us back significantly,” she noted on the campaign page. “On 10-27-20 we were again burglarized and cleaned out. We are now in danger of losing everything we worked so hard for.”

The campaign has raised over \$35,000 at the time of this post, surpassing its original goal of \$15,000.

“It’s been a real blessing,” said Scurry. “I appreciate everybody that reached out to even give us encouraging words and that are praying for us.”

Scurry is hopeful La'Vanter can bounce back from this massive financial loss.

"We as Black people, really need to reunite and come together," she said. "Destroying and tearing down our own people is not the answer."
